

ABOUT THE COLLEGE

Secondary Training College is a Government college of Teacher Training to have been founded by the British in 1906 in Mumbai and hence was so named. It was the First college in the then Bombay Presidency to award the Autonomous Diploma STCD from the year 1906 till 1922. After which it became affiliated to University of Mumbai to run the B.T. Program which today is known as the B.Ed. Program.

Currently Secondary Training College, Mumbai has become a Constituent of Dr. Homi Bhabha State University founded via Act VI, by the legislative Assembly on February 13th 2019. This is the first ever (Government Owned Cluster University Maharashtra State and third in the Country. It has its own Board of Studies and Faculty. The college is situated strategically at Dhobi Talao, housed in the heritage building, in the historic campus of the Elphinstone Technical School at CSMT in the prestigious South Mumbai area, Maharashtra.


The college offers Two Years Full time UG Program in Education (B.ED.) recognized by the NCTE (2015), which prepares teachers for the Secondary and Higher Secondary level schools and Junior Colleges. The eligibility for the B.Ed. program is graduation or post-graduation from any discipline with a minimum of 50% marks for student from open category, and 45% marks for student from reserved category, both domiciled and born in the State of Maharashtra and having acquired the qualifying Degree from a University within the State of Maharashtra. Admission procedure is centralized and is conducted by the State CET cell and verified by Admissions Regulatory Authority (ARA), Mumbai Maharashtra. The Director Higher Education (M.S.) being the Nodal Officer of the CAP, it is governed by DHE Pune, Maharashtra.

Fees is charged as per the prevailing government rules, and as prescribed by commissioner State CET Cell Mumbai. All relevant free ships and scholarships are made available to the students. Residential government hostel facility is available both for boys and girls.

The Secondary Training College underwent NAAC accreditation and was accredited with an (A) grade and a score of (3.23) in the year 2015 by NAAC, Bangalore for the second consequent time. Secondary Training College has a teaching staff that is highly experienced, competent, very helpful and disciplined.

The college is easily accessible by train services on either side (i.e. Central Railway and Western Railway). It is also very well connected via bus services. The college has a well-equipped Library with a rare books section. All the reference books are available in English, Marathi, Hindi, Sanskrit and Urdu Languages. A Computer Laboratory with internet facility is available for the students in the college and is currently undergoing renovation.
